Migrant

Entitlement:

(Services provided through partnership with Tulare County Office of Education)

Target Population:

A migrant child is identified when one of their parents has moved here to seek agricultural work. Some may not find work. If they are seeking work, they need to have a prior history of working in the fields.

They will qualify for 3 year. If after 3 years they haven't moved, they exit the program. Moving within the county does not qualify for a new qualifying date.

If they move within the 3 years, once they come back they will have a new start date for the 3 years.

The student must have an interruption in their schooling. Students must also move, not just the parent.

Going out of the country to visit family does not qualify for a new start date.

How it is implemented at Sundale:

Tutoring, summer school, snacks for students, and staff professional development

Goals:

Improve test scores, narrow achievement gap, inform and educate parents, staff training

Program Title:

Special Education

Entitlement:

Approximately - \$140,812 (Federal)

Approximately - \$135,397 (State)

Target Population:

Students with special learning disabilities, mental capacity, certain medical conditions, severely emotionally disturbed, and/or speech & language

How it is implemented at Sundale:

Certificated Personnel - coordinator of program - staff training, legal compliance, paperwork, meetings, follow-up on students and IEP's, 504's, and ILP's, oversee Response to Intervention (RTI), train and direct classified special services staff, research/develop/recommend curriculum and programs, assessments, coordinate services, communicate with administration and county, etc.

Classified Personnel - tutoring, summer school, reading lab, reading and math academies, RTI support, speech & language, perceptual motor, assessments, fine arts and special friends programs in a one on one or small group setting

Contracted Services - psychologist, speech & language specialist, and occupational therapist

County Services - psychologist, program specialist, mobility specialist, specialist for low incidence students (blind, deaf), trainings, assistance with reviews

Other - curriculum, assessments, technology, staff training, incentives/rewards, specialized academic supplies and equipment, RTI and TAT

Goals:

Assist students in meeting their potential and meet IEP, 504, or ILP goals, teach students compensation skills if necessary, improve performance in class and test scores, improve teacher effectiveness, improve emotional, social, behavioral and psychological well-being and skills, and strengthening preparation for college and careers

Measurement/Outcomes:

Definitions:

RTI (Response to Intervention) - This is all the early intervention strategies and programs a student goes through to help him or her succeed, before a referral to Special Services

TAT (Teacher Assistance Team) - A committee at each grade span (K-2, 3-5, 6-8) made up of teachers, specialists, and/or an administrator to discuss students that a teacher would like some input on or may be struggling in some areas of school life

504 Plan - A way to remove barriers and allow students with disabilities to participate freely in school

Program Title:

LCAP (Local Control Accountability Plan)

Approximately - \$604,798

Target Population:

English learners, socio-economic disadvantage, homeless or foster students

How it is implemented at Sundale:
