- III. Program Highlights
  - a. School Wellness triennial assessment and nutrition test results: Presented by Linda Allen

Every 3 years we do a wellness assessment to track the progress of state goals, it is posted on the school website. We found we did well and hit all the areas but we needed to address updating physical training and the smart stacks lists which we have now updated and listed on the school website. Completed in June 2020 we met 6 out of 6 goals.
- IV. Action Updates
  - a. Updated EL master plan:

The benchmark expectation form was updated. If the student is being evaluated for re-designation, they use this form. We added that dual emersion is not being offered at this time. The changes will be up for approval by the board at the January meeting.

  - b. Mrs. Gist discussed the ELOP (Expanded Learning Opportunities Program).

This program will offer opportunities for students to participate in enrichment and academic activities after the school day (opportunities would need to be offered to extend the day for students to be in school for 9 years) as well as during intercession times (30 days above the regular school calendar). This will be in place this next school year.

Mrs. Gist asked the group if there were ideas of opportunities to offer our students as well as individuals who would be interested in teaching. These opportunities can

include but not limited to art, physical fitness, academic, social emotional, music, technology, career technical skills, etc.

c. Comprehensive school safety plan: No updates

#### V. Advisory, Curriculum & Instructional Updates

a. EL update:

Sandy Cahill provided designated ELD lessons. She will be back in February to do walk through evaluations and assist any teachers who would like help.

b. Current District Assessment Data:

We transferred to a new data system. We have been ironing out the kinks and working on some changes. Joy Ashford shared the data results from the benchmarks. The Fall benchmark is was taken at the beginning of the year and the winter assessment was taken at the end of trimester one.

We are considering polling parents of students participating with tutoring and reading programs to get some feedback on what is working well.

c. LCAP input for upcoming plan:

Kindergarten winter camp is a 3 day camp. There is on-campus tutoring, reading and math skills for some grades. The kids that need the extra support will be on campus for the week in January prior to school starting.

Ideas: Older children helping with tutoring the younger children

During break we will think of other ideas for us to consider.
